## What is the Lodge?

- Located at Blessed Trinity in the old rectory
- It's a center for the youth and young adults
- It has a living room with board games and movies, a game room with pool, foosball, and air hockey, a full kitchen and a quiet study space
- It is a chance for students of both parishes to gather in fellowship and hangout prior to classes in a safe and fun environment.
- Stocked with soda/water for 25 cents and pizza for three dollars
- It is open for middle school every Wednesday prior to religious education classes
  - Open from 4:45-6:45pm
  - Supervised by at leaser two Safe Environment trained adults
  - Parents can drop off students whenever, but students must sign in when they arrive and remain at the lodge until they are walked over for classes
  - Students are walked over to classes at 6:45pm so they can participate in Fellowship of Christian Athletes in the gym
  - Students must have a signed permission slip on file to participate
  - It is not open on weeks when classes are not in session
